

## **Notice of Indemnification and Release Form**

Ashwood Farm, Three Fates Farm, LLC, and Lori K. Sargeant hereby give notice to the undersigned and the undersigned hereby acknowledges that Ashwood Farm, Three Fates Farm, LLC, and Lori K. Sargeant have no control over the horses and/or equipment, and/or instructors used in conducting and/or participating in riding lessons or horse related activities.

Ashwood Farm, Three Fates Farm LLC, and Lori K. Sargeant, hereby give notice to the undersigned and the undersigned hereby acknowledges that there are inherent risks and/or dangers involved in riding on and working around horses, which risks include bodily injury and death from using, riding, or being in close proximity to horses or farms, among other risks, and further, that both horses and rider can be minimally, seriously, or fatally injured in normal use, competition, and schooling as well as injuries occurring in a farm or stable.

"Inherent risk" of an equine activity means a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following:

- (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to Persons on or around the equine.
- (b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals.
- (c) Hazards, including, but not limited to, surface or subsurface conditions;
- (d) A collision with another equine, another animal, a person, or an object;
- (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person or the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

The undersigned does hereby agree to hold harmless Ashwood Farm, Three Fates Farm, LLC, and Lori K. Sargeant, and further releases them from any responsibility for accident, damage, injury, or illness to the undersigned or any horse owned or in possession of the undersigned or to any family, member, or spectator or any person accompanying the undersigned to Ashwood Farm.

The undersigned acknowledges that horseback riding is a dangerous sport, which can cause minimal, serious, or fatal injuries, notwithstanding this knowledge, the undersigned fully agrees and accepts any and all risk of injury arising from horseback riding.

The undersigned does hereby agree to hold harmless Ashwood Farm, Three Fates Farm, LLC, and Lori K. Sargeant (and any corporate body, partnership, agent, or any other entity associated with Ashwood Farm, Three Fates Farm, LLC, and Lori K. Sargeant) and further the undersigned does hereby release them from any and all liability and/or responsibility and further the undersigned does hereby agree to indemnify them for any and all damages resulting from any accident, and/or injury and/or illness to the undersigned or any horses owned by the undersigned or to any family member, or spectator or person accompanying the undersigned to or at Ashwood Farm.
